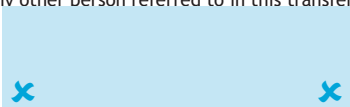
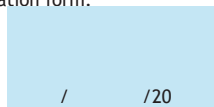

DECLARATION

We are required by HM Revenue & Customs to point out that it is a serious offence to make a false statement.

1. I hereby apply for membership of the Jessop Personal Pension Trust (the 'Trust') in accordance with the details and provisions contained in the 'Key Features of the Jessop Personal Pension Trust' and I agree to be bound by the Rules of the Trust. I have read the Key Features Document and kept a copy for my records.
2. I undertake that I will not require the trust funds or income from the funds to be paid to me other than where expressly provided under the Trust Deed and Rules of the Trust.
3. I undertake to notify Jessop Fund Managers Limited, in writing by 5 April in the relevant tax year or within 30 days (whichever is the earlier) when any of the following occur:
 - (i) I cease to be UK resident;
 - (ii) I cease to have relevant UK earnings;
 - (iii) I begin to have relevant UK earnings.
4. If I do not have relevant UK earnings during the current tax year, I confirm that I am either resident and ordinarily resident in the UK, or a Crown Servant (or have been for at least part of the year); or I am the spouse/civil partner of a Crown Servant (or have been for at least part of the year) and I agree to ensure that total contributions will not exceed £3,600 gross each year to the Trust and other approved personal pension arrangements.
5. I understand that the benefits under the Trust are not capable of being surrendered, assigned, commuted or transferred except as permitted by the Finance Act 2004.
6. I declare that the total contributions to any registered pension schemes in respect of which I am entitled to relief from income tax will not exceed the higher of:
 - (a) the basic amount (currently £3,600); or
 - (b) my relevant UK earnings (basically earnings from a trade, profession or employment which are liable for UK Income Tax) for that year.
7. I understand that, if I have selected LifePlan, my Account holdings will be switched automatically according to a predetermined basis as explained in the Key Features document.
8. I understand that this application is in respect of 11 separate arrangements (or contracts) and that all contributions and other payments to the Trust will be applied as follows:-
 - (i) my Protected Rights Fund (if any) will be applied to one single arrangement, and
 - (ii) any other payments to my Account will be applied in equal parts to ten other separate arrangements.
9. I undertake to indemnify Jessop Fund Managers Limited against any lifetime allowance charge or other tax charge in respect of my Account for which Jessop Fund Managers Limited becomes liable. I agree that Jessop Fund Managers Limited may discharge that indemnity on my behalf by setting off my liability to Jessop Fund Managers Limited against my Account or benefits payable under my Account.
10. In the event of my death, I instruct Jessop Fund Managers Limited on receipt of notice of my death to transfer the full value of unit holdings into the Jessop Cash Personal Pension Fund. (This is designed to protect your beneficiaries against possible short-term market fluctuations that might occur before we are in a position to pay the benefit out.)
11. I declare that the answers given in this application are to the best of my knowledge and belief correct and complete.
12. I consent to Jessop Fund Managers Limited obtaining information and details from the trustees, administrators and/or insurers of the scheme or arrangement and any other person referred to in this transfer application form.
